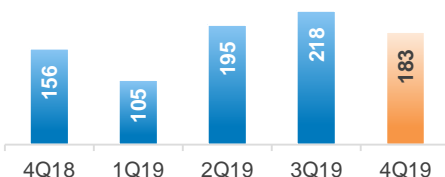

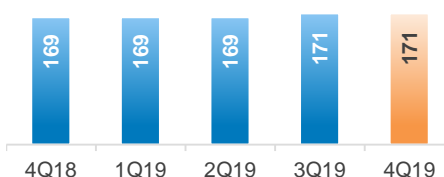

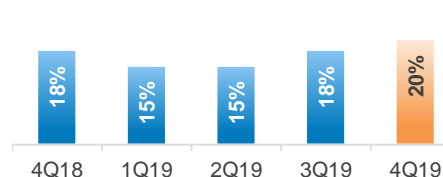
Premiums written (\$ millions)



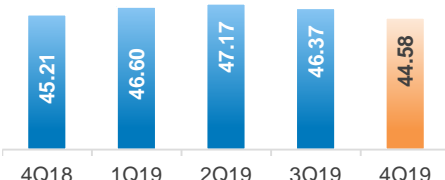
Premiums earned (\$ millions)



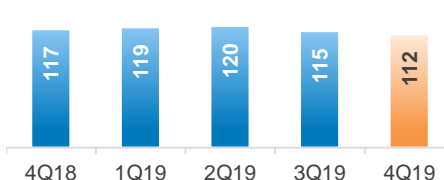
Loss ratio (%)



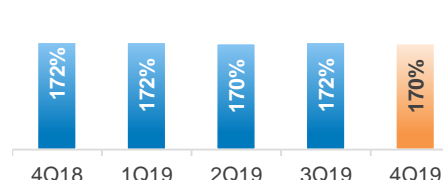
Book value per share (diluted, incl. AOCI)

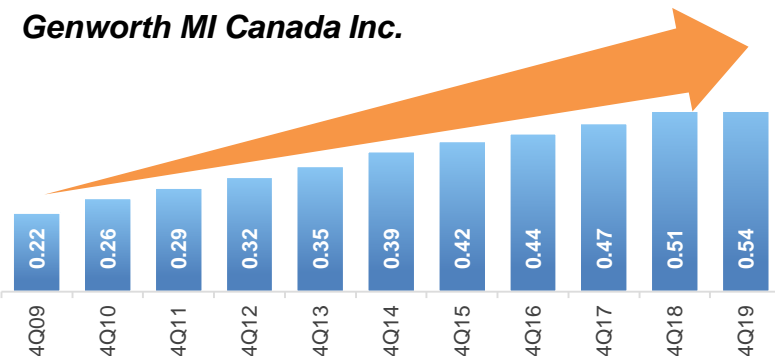

History of quarterly dividend increases

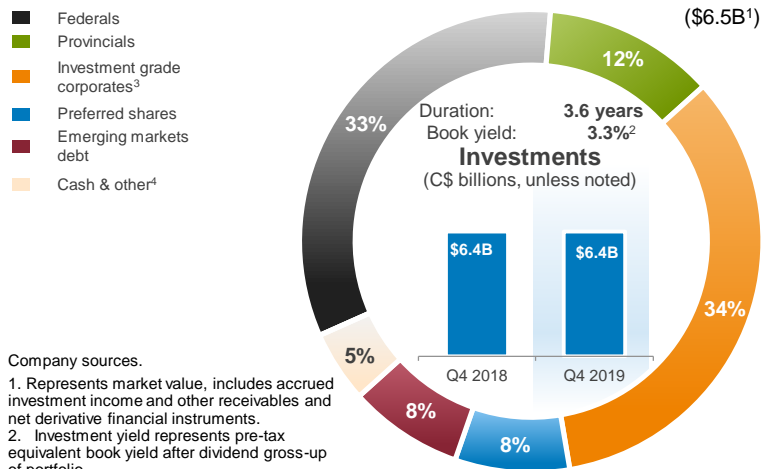
Genworth MI Canada Inc.
