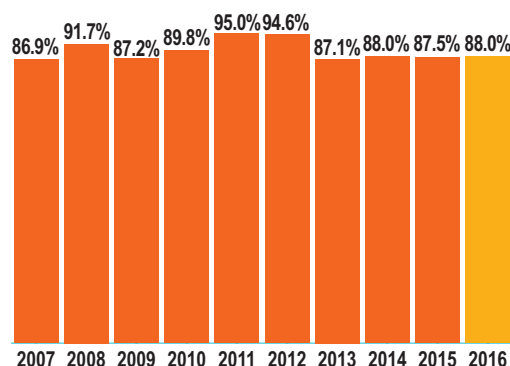

P&C Combined Ratio¹

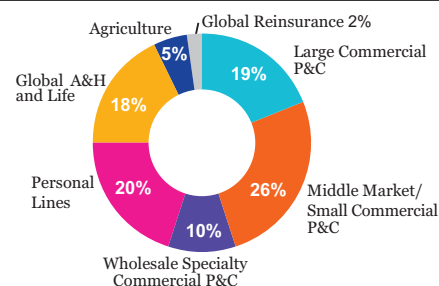

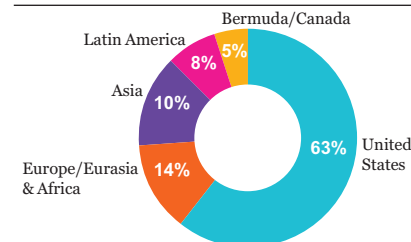
