**14** Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ On March 14, 2012, MyFonts Inc. distributed the stock of Marlborough Software Development Holdings ("MSDH"), its wholly owned subsidiary, to its shareholders.

**15** Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ The distribution of the stock of MSDH reduced the basis of the shareholders' stock, as there was no current or accumulated earnings and profits. Therefore, the distribution is first an adjustment to basis, and then taxable. The value of the distributions is \$.8662 per share.

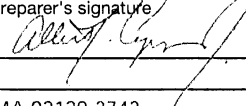
