# Virtus Stone Harbor Emerging Markets Income Fund Announces Adviser Update

HARTFORD, Conn.--(BUSINESS WIRE)-- **Virtus Stone Harbor Emerging Markets Income Fund** (NYSE: EDF), which is managed by Stone Harbor Investment Partners, today announced that as a result of a company legal entity transition Virtus Investment Advisers, LLC (VIA) has replaced Virtus Alternative Investment Advisers, Inc. (VAIA) as the Fund's adviser. As a result, also effective January 1, 2025, VAIA's rights and obligations under the investment advisory, subadvisory and expense limitation agreements for the Trust have been transferred to, and assumed by, VIA.

Both VIA and VAIA are wholly owned indirect subsidiaries of Virtus Investment Partners, Inc. No changes have been made to the investment advisory fee rates payable by the Fund, the Fund's subadviser, or the portfolio managers managing the Fund.

**Virtus Stone Harbor Emerging Markets Income Fund** is a non-diversified, closed-end management investment company that is managed by **Stone Harbor Investment Partners**. The Fund's primary investment objective is to maximize total return, which consists of income and capital appreciation on its investments in emerging markets securities.
