## The Container Store Environmental Policy 2021

#### The Future is Green

We are continuously looking for solutions that will help reduce our overall energy consumption and are actively transitioning to renewable energy.

As part of our commitment to green energy, our stores, distribution centers, and corporate office power use is offset by our investment in **100% renewable** energy. We are also looking for new opportunities to reduce our overall greenhouse gas emissions and carbon footprint.

In addition to establishing our very first **Renewable Energy Credits (REC)** program, The Container Store is also a member of the **Environmental Protection Agency's (EPA) Green Power Program**, which will allow us to stay informed on trends in the green power sector.

## Investing in LED

Using LED lights not only saves a vast amount of energy but also has a positive impact on the environment by reducing overall energy consumption. Making the switch to a full LED lighting plan can result in up to 64% energy savings per fixture in each of our stores. It can also reduce the high waste-to-landfills impact of regular lightbulbs.

In 2018 we started the journey to include **full LED lighting in all future stores**, inclusive of our distribution center in Aberdeen, MD. In fiscal 2021 we started a retrofit program for some of our existing store fleet with plans to retrofit six stores. We plan to continue the program until all stores are complete. The new LED retrofit program will result in overall **energy savings in our stores**.

We are dedicated to searching the world over to bring our customers sustainable product options. We offer products made from renewable and recycled materials, as well as products that promote the health of our homes and environment. We are proud to make a difference through our commitment to sustainability and we are continuously working to introduce more sustainable solutions across the following main categories:

We continue to look for innovative solutions to reduce packaging and product waste, and we promote the use of recyclable materials, where possible. We strive to divert waste from the landfill at our stores and are actively working on establishing waste reduction goals.

For example, through a partnership with one of our packaging vendors our use of **100% recyclable corrugate boxes** has contributed to the following savings in 2020:

15,582,000 gallons of water saved

**37.842 trees** saved

2,226 tons of CO2 prevented from operation activities

7,346 cubic yards diverted from landfill
