The agreements, now in effect, expand available care choices for Humana Medicare Advantage members of Health Maintenance Organization (HMO), Preferred Provider Organization (PPO), and Private Fee-for-Service (PFFS) health plans in Pennsylvania and New Jersey through in-network access to the following seven Trinity Health hospitals:

- [Our Lady of Lourdes Medical Center](#) and [Lourdes Medical Center of Burlington County](#) in Camden and Willingboro, New Jersey, respectively
- [St. Francis Medical Center](#) in Trenton, New Jersey

The agreements also provide in-network access to the more than 700 primary care and specialty physicians in Greater Philadelphia and Southern New Jersey employed by these hospitals.

"Our work with Humana reflects a shared commitment to providing quality health care for people with Medicare, and a dedication to their health and well-being," said Michael Hammond, chief financial officer, Trinity Health Mid-Atlantic Region. "We are very pleased."

"This network expansion in Southeast Pennsylvania and Southern New Jersey is part of Humana's commitment to providing additional options for care for our local Medicare Advantage members," said Humana regional president Eric Bohannon. "Increasing access to care is essential in supporting our members as they strive to lead healthy lives."
