(October 15, 2025) -- Ephrata, PA – ENB Financial Corp (OTCQX: ENBP), declared a fourth quarter cash dividend today, October 15, 2025, of \$0.18 per share, maintaining the same dividend paid in the fourth quarter of 2024 and paid in the third quarter of 2025. The dividend applies to all shareholders of record as of November 14, 2025, and is payable on December 15, 2025. Shareholders will receive \$0.18 for each share of ENB Financial Corp common stock owned as of the record date.
