

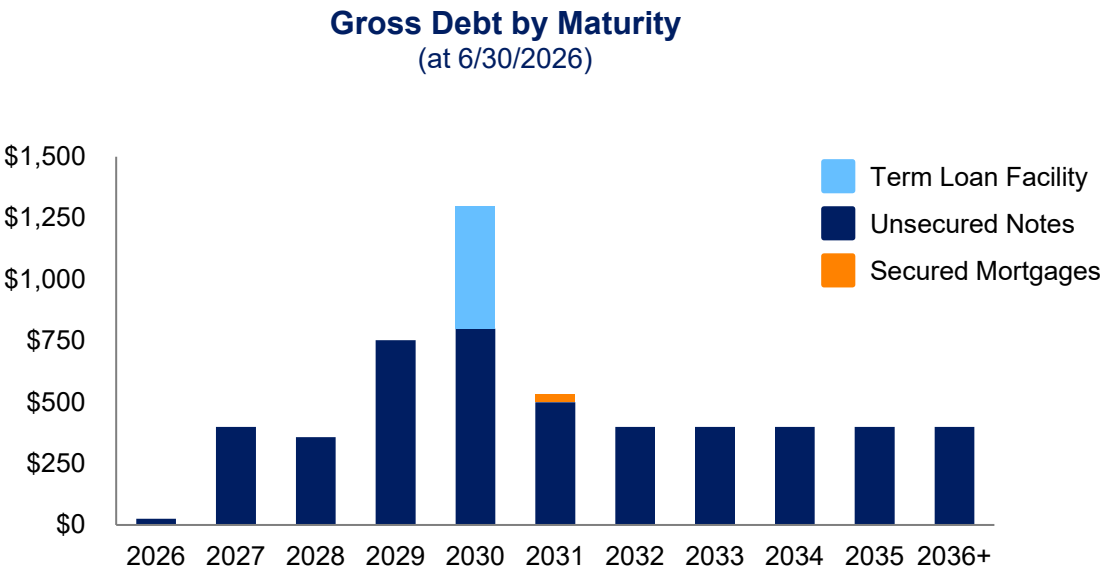
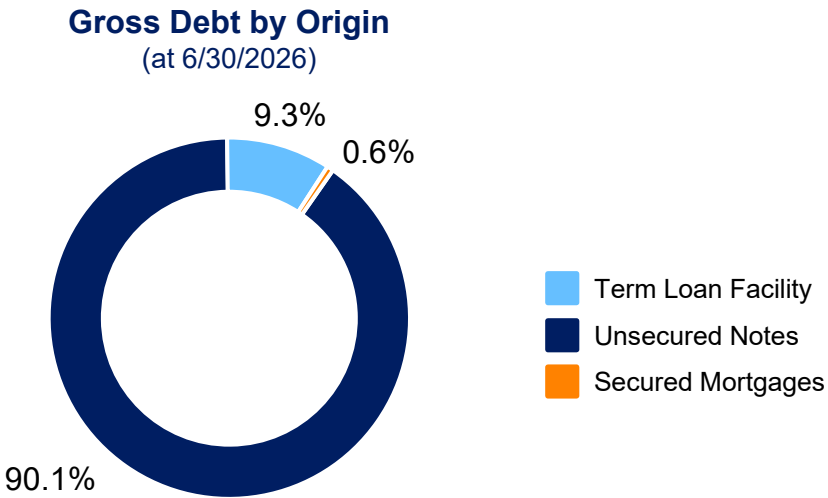
Net Debt Level
