Patti Poppe



Chief Executive Officer



Patti Poppe joined PG&E in January 2021 after five years as President and CEO of CMS Energy and its principal subsidiary, Consumers Energy, where she focused on connecting the utility more closely with its customers and adapting lean operating system principles throughout the business. In her decade-long career with the Michigan company, she also served as Senior Vice President of Distribution Operations, Engineering and Transmission; Vice President of Customer Experience, Rates and Regulation; and Vice President of Customer Operations.

Previously, Patti served as a Power Plant Director at DTE Energy. Prior to joining DTE Energy, Patti held a variety of plant management positions in the automotive industry.

Patti is a member of the Board of Directors for Whirlpool Corporation, Associated Electric & Gas Insurance Services Limited, Edison Electric Institute, Institute of Nuclear Power Operations, American Gas Association, Electric Power Research Institute and the California Chamber of Commerce.

Patti earned a master's degree in management from the Stanford University Graduate School of Business and received a bachelor's degree and master's degree in industrial engineering from Purdue University.

Sumeet Singh



Executive Vice President, Operations and Chief Operating Officer



Sumeet Singh is responsible for all of PG&E's operations, including Gas, Electric and Generation, as well as the Safety and Wildfire & Emergency Operations teams. In this new role, he is seeking to further increase connectivity between risk and safety and the operation's landscape to enable operational execution excellence across the board.

Sumeet previously served as Executive Vice President, Chief Risk Officer and Chief Safety Officer, overseeing the company's integrated workforce health and safety strategy, its safety culture, and management of both operational risks such as wildfires, nuclear, dams, natural gas, natural disasters and non-operational risks such as cybersecurity, pandemic and others.

Sumeet has held numerous other leadership roles within PG&E, including serving as the Senior Vice President, Chief Risk Officer, and Vice President, Asset Management and Community Wildfire Safety Program. This program consists of measures intended to further reduce risk on PG&E's electric system and includes partnering with communities on wildfire safety and prevention efforts. Key facets include real-time monitoring and intelligence, new and enhanced safety measures, system hardening and resiliency efforts.

Sumeet also served as Vice President of Portfolio Management & Engineering in PG&E's Gas Operations, responsible for planning, prioritizing and providing oversight of Gas Operations' portfolio of work. Additionally, Sumeet served as Vice President, Asset & Risk Management in PG&E's Gas Operations, responsible for overseeing all aspects of records management, developing a clear understanding amongst the workforce of codes and standards, identifying and managing a rigorous risk-based approach to understanding PG&E's natural gas system, and leveraging technology to enhance and streamline operations.

Joining PG&E in 2000 as an engineer, Sumeet also worked in various natural gas distribution and transmission engineering roles, as well as in the Finance and Energy Procurement functions. Sumeet has also served as the Gas Safety and Integrity Officer at Picarro Inc., leading a global organization focused on the growth of an innovative technology based on hardwareenabled analytics informing asset management solutions to drive a safer and cleaner natural gas system by improving the overall risk spend efficiency.

Sumeet holds a bachelor's degree in Civil and Environmental Engineering from the University of California, Berkeley, and a Master of Business Administration degree from UCLA Anderson School of Management. He is a registered professional Civil Engineer in the State of California. Sumeet serves on the board of GTI Energy, a leading research and training organization focused on developing, scaling and deploying energy transition solutions.

Carolyn Burke joined PG&E in 2023 and has extensive leadership and turnaround experience in Fortune 500 energy and financial services companies. She was previously Executive Vice President and Chief Financial Officer at Chevron Phillips Chemical Company. She also served as Executive Vice President, Strategy at Dynegy, where she was part of the executive management team that helped lead the company's emergence from bankruptcy to become a successful power generation and retail electric company.

Prior to Dynegy, Carolyn served as Global Controller, Investment Bank, Global Commodities at JP Morgan Chase, where she supported its business expansion and built finance commodities expertise. Before this, she was Vice President and Corporate Controller at NRG Energy, Inc., where she helped rebuild its finance team and strengthen financial operations as part of a turnaround.

Carolyn became Chief Financial Officer of PG&E Corporation on May 4, 2023. In this role, she is responsible for audit, accounting, financial planning, investor relations, treasury and tax functions.

Carolyn earned a Master of Business Administration in Finance and Strategy at The University of Chicago Booth Graduate School of Business, and a Bachelor of Arts in Economics and Political Science at Wellesley College.

Carla J. Peterman



Executive Vice President, Corporate Affairs and Chief Sustainability Officer



Carla J. Peterman has spent her career focused on California's energy policy and regulatory landscape. At PG&E, she oversees the company's regulatory, legislative, sustainability, and charitable strategies, all focused on delivering for the customers and communities that PG&E serves in Northern and Central California.

Prior to joining PG&E in 2021, Carla served as Senior Vice President of Strategy and Regulatory Affairs at Southern California Edison. Before that, she served a six-year term as a Commissioner of the California Public Utilities Commission (CPUC).

A steadfast proponent of clean energy, at the CPUC Carla led the adoption of the first utility energy storage mandate in the country, the approval of nearly \$1 billion of utility investments in electric vehicle charging infrastructure, the adoption of utility energy efficiency goals and business plans, and the implementation of California's Renewables Portfolio Standard.

Before her CPUC appointment, Carla served on the California Energy Commission, where she was the lead commissioner for renewables, transportation, and natural gas. She also is a former board member of The Utility Reform Network, an organization that represents consumers before the CPUC and California Legislature.

In 2019, Governor Newsom appointed her to chair the Commission on Catastrophic Wildfire Cost and Recovery. She currently serves as a member of the Federal Reserve of San Francisco Economic Advisory Council. She has also served on various other boards, including the National Association of Regulatory Utility Commissioners (NARUC), NARUC's Energy Resources and Environment Committee (Vice-Chair) and the external advisory board for Sandia National Laboratories' Energy and Homeland Security Portfolio.

Carla holds a BA from Howard University, a PhD in energy and resources from the University of California, Berkeley and MS and MBA degrees from Oxford University, where she was a Rhodes Scholar.

Prior to that, she served as NextEra's Chief Integration Officer for the company's acquisition of Gulf Power and two other acquisitions. She also served in several other senior operational and leadership roles including Vice President, Customer Service for Florida Power & Light Company. Marlene has a wide breadth of experience including delivering best-in-class customer service, safety improvements, digital transformation, smart grid enablement, data analytics and artificial intelligence deployment, cultural transformation and emergency response to natural disasters.



Major Infrastructure Delivery is accountable for the company's program to underground 10,000 miles of electric distribution lines to reduce wildfire risk, the System Inspection Program to identify potential risks to the safety and reliability of the system and Vegetation Management to ensure the safe and reliable delivery of electricity. Peter joined PG&E in 2012 and has held several leadership positions with increasing responsibility. Previously, he served as Senior Vice President of Vegetation Management & System Inspections.

Peter began his career at Brooklyn Union Gas and has over 30 years of experience in the utility industry, including serving in leadership roles with National Grid that spanned across multiple states. Throughout his career, Peter has been instrumental in leveraging lean operating systems to improve safety culture and performance by engaging those closest to the work.

Mark Quinlan oversees the Emergency Preparedness & Response, Wildfire Preparedness and Emergency Field Operations organizations. He is the lead for the company's Public Safety Power Shutoff (PSPS) and Enhanced Powerline Safety Settings (EPSS) programs, both of which have proven successful in reducing wildfire risk. Also reporting to Mark are the Safety and Infrastructure Protection Teams, which help to protect PG&E crews defend critical utility infrastructure and prevent potential wildfire sources.

Mark has been with PG&E for nine years and has 32 years of experience in the electric industry.

Previously, Mark was PG&E's Vice President of Transmission and Distribution System Operations. In prior roles, he was Vice President of PSPS Operations and Execution and interim head of PG&E's Electric Transmission Operations. He also has held positions of increasing responsibility within the Emergency Preparedness & Response, Electric Transmission and Electric Distribution Grid Operations organizations for PG&E.

Before PG&E, Mark spent 22 years at Commonwealth Edison in operations, safety and humanperformance leadership roles.

Aaron August is focused on the creation of transformative, scalable solutions to interlocking utility challenges through the development of third-party partnerships and the deployment of new technology that directly accelerates PG&E's long-term strategy. He has oversight of non-traditional utility partnerships, R&D, solutions management, load management, clean energy transportation and business development.

Aaron joined PG&E in 2013. Prior to his current role, he was responsible for the strategy, design, implementation and effectiveness of PG&E's energy programs including energy efficiency, demand response, distributed generation, low income and clean transportation. 


Guest Speakers

Brian Rice



President of California Professional Firefighters



Brian K. Rice has been involved with the California fire service and the firefighter labor movement for more than three decades. He spent over 30 years with the Sacramento Metropolitan Fire Department, rising to the position of Deputy Chief of Operations. As a firefighter, Brian served as a Rescue Company Captain and was often called on to manage complex scenes and resources on a variety of incidents, including medical calls, major structure fires, HazMat and technical rescue incidents. During this time, Brian was certified as a Hazardous Materials specialist and technician. In recent years, he and fellow labor leaders have supported line firefighters at the State's largest fires, including Dixie, Woolsey, Carr and Camp (Paradise).

Brian was also twice elected as president of Sacramento Area Firefighters Local 522, serving a total of 12 years in the position. In 2018, Brian was elected president of California Professional Firefighters (CPF), representing close to 35,000 front line firefighters and emergency medical services personnel statewide. As CPF President, Brian is a statewide leader in advocating for firefighter's wages, hours and working conditions. While that takes many forms, Brian has prioritized ensuring that CPF members are the best trained, most effective, and best equipped firefighters in the world. Brian has joined CPF affiliates in fights to ensure adequate funding and increased staffing to meet the new and evolving demands of the profession. In 2020, he led an effort to ensure that local revenue was protected in the context of Proposition 19, which the California Legislative Analyst has estimated will increase local property tax revenue, thus supporting fire departments throughout the State.

In addition to his role as CPF president, Brian also is an active participant on many state-wide task forces, boards and working groups. He serves as co-chair of the California Firefighter Joint Apprenticeship Committee, setting professional standards and improving education and training for fire service throughout the state. He is also the chair of the non-profit California Fire Foundation, providing support for the families of fallen firefighters, disaster relief for communities, and grants to help strengthen community safety. As a labor leader, Brian represents firefighters as a Vice President on the Executive Council of the California Labor Federation, AFL-CIO.

Brian also serves on the California FIRESCOPE board, a partner with the California Office of Emergency Services. As a member of the FIRESCOPE Board of Directors, Brian has a role in maintaining and improving FIRESCOPE products and services including Incident Command System (ICS) and the Multi-Agency Coordination System (MACS). He also serves on the State board of Fire Services and is a member of both the IAFF Federation of State and Provincial Professional Firefighters and the IAFF Hazardous Materials Advisory Board.

Ann Patterson



Cabinet Secretary for California Governor Gavin Newsom



Ann Patterson advises the Governor on policy and oversees agencies and departments within the Administration.

Previously, Ann served as the Governor's Legal Affairs Secretary, advising the Governor's Office on a broad range of legal issues and overseeing litigation to which the Governor or the State of California is a party.

Governor Newsom also appointed Ann as Legal Counsel to the Governor's Energy Strike Team, which oversaw the state's response to the bankruptcy of Pacific Gas & Electric Company.

Ann has more than 20 years' experience in the public and private sectors in California and nationally. Prior to joining the Newsom Administration, Ann was a partner at Orrick, Herrington, and Sutcliffe, where she practiced from 2005 until 2018.

She previously served as Special Assistant for California Attorney General Bill Lockyer, where she managed numerous policy initiatives including a \$50 million statewide project to identify and perform DNA testing on warehoused evidence from unsolved sexual assault cases. Ann also served as a law clerk for the Honorable Frank C. Damrell (ret.) on the U.S. District Court for the Eastern District of California.

Russell Hancock



President and Chief Executive Officer, Joint Venture Silicon Valley



Russell Hancock is President & Chief Executive Officer of Joint Venture Silicon Valley, a position he has held since 2003. In these roles Dr. Hancock is best described variously: as a civic leader, community gatherer, institution builder, civic entrepreneur, social scientist, and outspoken advocate for regionalism. Since taking the helm he has grown the size of the organization ten-fold; assembled a potent board filled with mayors, CEOs and university presidents; built strategic partnerships; recruited a highly talented staff; founded the Institute for Regional Studies and launched initiatives that are delivering measurable results to the region.

Russell is also the founder of the annual State of the Valley conference, a "town hall" meeting attracting more than 1,500 leaders for a day spent in dialogue and discussion about the Valley's challenges and opportunities. The conference features the release of the Silicon Valley Index, a document now receiving national and international attention.

Bill Dodd



California State Senator, District 3



Sen. Bill Dodd represents California's 3rd Senate District in the heart of the scenic North San Francisco Bay Area. The fifth-generation Californian grew up on his family's small Napa farm and was a successful business owner before being elected to the Napa County Board of Supervisors, the state Assembly and the state Senate, where he is now serving his second term.

Sen. Dodd's district includes all of Napa and Solano and Yolo counties and portions of Contra Costa, Sacramento and Sonoma counties. He is chair of the Senate Governmental Organization Committee and is a member of the Transportation Committee, the Energy, Utilities and Communications Committee, the Business and Professions committee and the Insurance Committee. He is co-chair of the Senate Select Committee on California's Wine Industry and the Legislative Delta Caucus.

Sen. Dodd's work has spanned many topics – from improving public education and the environment to data privacy and protecting seniors. During his tenure, he has established himself as the most prolific lawmaker in the Legislature, authoring 99 bills that have been signed into law. As a senator representing wildfire-torn Napa and Sonoma counties, he has been a leader on wildfire safety and prevention legislation.

Steven Herber



President of Adventist Health St. Helena



Dr. Steven Herber completed his plastic surgery training in 1992 at Yale University School of Medicine, where he was also a faculty member. He received his medical degree and surgical residency training at Loma Linda University School of Medicine, where he later returned to teach in the Department of Surgery after completing a fellowship in pediatric reconstruction and maxillofacial surgery. After teaching at his alma mater for 5 years, he founded the St. Helena Institute for Plastic Surgery in 1998 and has practiced in the upper valley for 25 years. He accepted an executive role at St. Helena Hospital in 2011 and became its president in 2014.

Steve is passionate about education, supporting professional development in hospital staff and mentoring young people who are interested in health care careers. He serves as a trustee for a local grade school and college and is president of his medical school alumni association.

He also co-chairs the Blue Zones project for the Upper Napa Valley with the goal of improving the health and well-being of the community.

Even today, Marc continues to oversee the family's vineyards across Northern California, working hands-on to ensure they remain properly cared for.

Outside of the winery, Marc's many interests extend across food, wine, civic organizations, and conservation. He's also an avid outdoorsman. He and his wife, Janice, have four daughters (part of the fourth generation of the family).

Before taking the helm at Charles Krug, Flat Top Hills has been her personal passion project where she partners closely with Head Winemaker Randy Herron to drive style and collaborate on final blends.

Angelina currently consults for a number of wineries within Napa and Sonoma Valley, including Brasswood Cellars, Harrow Cellars, Allora Vineyards, Castlevale and Illum, while also crafting her own wines, Aloft and Dark Matter Wines, alongside her sisters.


