- 1. Why are you still hosting an AGM if shareholders are not able to attend in person?
 - Swiss laws require the company to hold an annual meeting. Due to restrictions on public gatherings arising from the current COVID-19 situation, shareholders are directed to send in their proxy instructions to the independent proxy (Hartmann Dreyer Attorneys-at-Law).
- 2. Why did you not choose to host a virtual AGM like other companies are doing?
 - Swiss law currently does not permit the hosting of a virtual AGM.

3. Can I vote using a power of attorney?

- Votes cannot be determined without granting power of attorney to the independent proxy.
- 4. Can I submit my vote on your website? What is the deadline for voting?
 - Shareholders with the right to vote as of April 27, 2020, will receive instructions to cast their vote exclusively through our proxy representative. The deadline for casting your vote for the 2020 Annual General Meeting is April 30, 2020.
- 5. I did not purchase Alcon shares. How do I own Alcon shares?
 - Alcon was a spin off of Novartis in April 2019. Novartis shareholders received one share of Alcon for every five Novartis shares owned.

6. Why is Alcon postponing their 2019 dividend proposal?

• Given the unprecedented uncertainties of the outbreak, we believe it is necessary to adjust our financial priorities in order to conserve liquidity in the near term.

• Protecting our liquidity and capital base will strengthen our ability to weather the economic uncertainties resulting from the ongoing global health crisis. Postponing the dividend until 2021 is only one of the many actions we are taking to preserve liquidity while protecting our associates.
